

**Brevard Christian Home Educators, Inc. Application for Membership**

**PURPOSE:**

This corporation is organized exclusively for educational purposes which include, but are not limited to, the supporting of parents who choose to educate their children at home, and the establishment and operation of a private Christian School for home educating families. We are in association for encouragement and mutual edification of those who recognize the scriptural imperative and constitutional right to so educate their children. We place a strong emphasis on spiritual maturity and training along with the other educational disciplines. Our common goal 'is to see our children excel in every area of growth: spiritually, academically, physically, emotionally and socially. The character of this corporation is defined by the Old and New Testaments of the Holy Scriptures.

**STATEMENT OF FAITH:**

We believe that the only true living God, creator of all the universe and all in it (living and nonliving), is a personal God. We believe that God the Father sent God the Son, the Messiah, to earth and that He lived a perfect (sinless) life of obedience to the Father. We believe that He was crucified for our sins, that He was buried, and the third day He physically rose from the grave never to suffer or to die again. We believe the Son of God ascended to the Father and is seated at the Father's right hand as Lord of Lords and King of Kings. We believe Jesus Christ to be the Messiah as promised in the Old Testament. We believe in the Holy Spirit, the third person of the Godhead. We believe that the Holy Spirit is given to God's children. We believe that the Holy Spirit is active in and upon the lives of those who are born again, and who submit to His workings. We believe the Holy Bible as contained in the Old and New Testaments has given the parents of children the final authority and responsibility for the training and education of their children. To God the Father, the Son, and the Holy Spirit we and our children owe absolute allegiance and obedience.

**Important Notes**

1. BCHE operates on a 51% rule. What this means is that parents are required to personally teach their children at least 51% of the time. This still leaves the opportunity for tutoring and a part-time co-op. Exceptions will be made on an individual basis for dual-enrollment and other special conditions.
2. BCHE reserves the right not to approve any Application for Membership and the right to revoke membership if any information has been misrepresented or if the terms of agreement for membership have been defaulted upon. If your Application for Membership cannot be approved, BCHE will refund your monies and send you a letter of explanation.
3. BCHE requires at least one Parent to attend both the January General Meeting and the Annual Business Meeting to remain a Member In Good Standing.
